## Ta in Newborn Screening?

Newborn Screening ej juōn an Public Health burokraam in kakōlkōl ñan nañinmij ko rellap im **ewor kilen kōmadmōdi ak ewor wāwein bōbraiki**. Ñe jemlōk ko an juōn niñniñ ej kalikkar ke ewōr juōn ian nañinmij kein ippān, emaroñ jino bōki kōmadmōd ko mokta jen an enjaki kakōlle ko.

## Ewor 3 kain kakōlkōl ilo NBS eo:



**Bōk Bōtōktōk:** Nāāj bōk jeppo bil in bōtōktōk jen jimin neen niñniñ eo im likit ion juōn Newborn Screening card. Innem, jilkinlōk ñan etāle ilo jikin bōk bōtōktōk eo an state.



**Kakōlkōl Lojilni:** Nāāj kakilene lojilnin im kein roñjake eo tok jen kōmelij eo an in lāle ñe rej roñlōkijan. Ñe rejjab, innem alikkar ke ajiri eo ejarroñroñ.



**Kakōlkōl Joñan Oxygen:** Ewor juōn kein joñe oxygen eo ilo bōtōktōk, me emāroñ loi nañinmij in menono ko rellap ak Critical Congenital Heart Disease (CCHD).

- ❖ ~1 ibwiljin 25 niñniñ ko rej lotak tok kin nañinmij in menono
- ❖ ~1-2 ibwiljin 1000 niñniñ ko me euñ aer allōñ ej lotak kin jarroñroñ
- ❖ ~1 ibwiljin 200 niñniñ ko rej kakōlkōl iloan NICU eo, ej jarroñroñ
